CONSTRUCTION TYPE	CONSTRUCTION COSTS (2021)
NEW SERVICE DROP	<ul style="list-style-type: none"> • \$400 aid to construction fee for each metered service • Required meter location is on the outermost sidewall of home including attached garages - must be within 10 feet from building corner nearest closest delivery point (Policy 310) • \$10/ft over 100 ft • \$10/ft for driveway crossings • \$800 for armor cable
NEW APARTMENTS, COMMERCIAL THREE-PHASE PRIMARY SERVICE, AND SUBDIVISIONS	<ul style="list-style-type: none"> • \$1/amp connect fee • \$10/kVA of transformer capacity • Primary line extension allowance per Policy 304 • \$1,000 per crossing for subdivision road bores
NEW SINGLE-PHASE PRIMARY SERVICE	<ul style="list-style-type: none"> • \$1/amp connect fee • \$10/kVA of transformer capacity for transformers greater than 50 kVA for one single metering point • Primary line extension allowance per Policy 304
NEW DRAIN TILE PUMP, PASTURE PUMP, SIGN, OR OTHER LOW-USAGE SERVICE	<ul style="list-style-type: none"> • \$1/amp connect fee • \$10/kVA of transformer capacity over 50 kVA single-phase • No line extension allowance per Policy 304
SERVICE CAPACITY UPGRADE, SINGLE- OR THREE-PHASE	<ul style="list-style-type: none"> • \$10/kVA of transformer capacity for any three-phase, single-phase >50 kVA and \$1/amp upgrade • Credit for existing transformer kVA • Additional charges may apply depending on the extent of revamp
PRIMARY REVAMP, SINGLE-PHASE TO THREE-PHASE SERVICE (POLICY 304)	<ul style="list-style-type: none"> • Provide 500 ft of line extension at no cost • No depreciation of existing line • \$10/kVA of new net transformer capacity and \$1/amp
NEW SECURITY LIGHTS	<ul style="list-style-type: none"> • \$800 fee for new light on a new pole • \$200 fee for new light on an existing pole • \$10/ft light wire extension
COLD WEATHER CHARGES	<ul style="list-style-type: none"> • Nov. 1 - 14: \$5/trench foot • Nov. 15 - 30: \$10/trench foot • Dec. 1 – TBD by CCEC: \$16/trench foot • Cass County Electric Cooperative reserves the right to suspend cable installation due to weather or ground conditions.

All services must follow policy 310 Conditions of Service (available at CassCountyElectric.com). Additional charges may be assessed for bores, soil or weather conditions, or for any other unforeseen issues. Requests for power made after Oct. 15 may not make the current year's construction schedule. A 50% payment of the total cost of construction will be required prior to construction for all new construction, line extensions, and conversions.
